Children's Behavioral Health System Transition Plan

Only 3% of the children in IA are currently uninsured.

- July 2020: Regions will be a point of entry for services and help to coordinate services for children. Current region service coordinators meet the requirements and will provide this service through our current intake process.
- Out-patient funding for uninsured children based on a sliding fee scale, 500% of the poverty level. Still gathering data to determine if there will be additional points of entry for applications and if the region will need to contract with additional providers.
- July 2021: Have a CSRS home for children. Lot of details to be determined. An RFP will likely go out after new fiscal year. Spread the word or contact the region if your agency is interested.
- Crisis Stabilization Community Based Services: provider to go into the home and assist with crisis.
- Mobile Crisis: Currently provided by Heartland Family Service and already available to families/children. They are currently called out by law enforcement. There was a meeting in Cass Co. last month to discuss barriers. Mobile crisis is piloting in two schools in the Northern area of the region to see how their service could work without law enforcement presence.
- In-Patient Treatment: Children without insurance may be eligible for payment from the region.
- Early identification and Assessment. State Board is developing an assessment tool.
- Education component: Regions to gather data.
- Advisory Board requirements.

Advisory Board

The region is re-structuring both the adult and children advisory boards. If interested complete an application and submit it to the region. The requirements for the make-up of the Boards is on the application.

There is some concern state-wide about the change in voting parties now written into legislation to be given voting rights as the BOS feel they were elected to make funding decisions and don't want others to have the ability to vote on levy issues, etc...
