**Approve Agenda-** Motion made by Steve Kenkel and second by Randy Hickey to approve the agenda. Motion passed unanimously.

**Approve August 2020 Meeting Minutes-** Motion made by Chuck Morris and second by Steve Kenkel to approve the August 2020 meeting minutes. Motion passed unanimously.

#### Region Finance Information -

**August 2020 Financial Reports-** Motion made by Mark Peterson and second by Randy Hickey to approve the August 2020 financial reports as presented. Motion passed unanimously.

**Iowa Balance of State Coordinated Services Regions MOU-** Danelle Bruce explained that signing of the MOU would allow the region to participate in meetings to discuss needs for homeless individuals as part of the coordinated entry group. Motion made by Chuck Morris and second by Mark Peterson to approve the signing of the Iowa Balance of State Coordinated Services Regions MOU. Motion passed unanimously.

**Legislative and COVID Related Updates-** Suzanne Watson shared that ISAC legislative priorities for the upcoming session include pushing back the timeline of implementation of some of the new adult and children's services by 1 to 2 years. An additional priority is to push back the 40%

fund balance requirement for the regions to current (July 2021). There were no COVID updates today.

**CARES Act Grant Applications**- Suzanne Watson gave an overview of the grant applications submitted to the region. The group discussed expenses that may be payable according to the grant in general terms. Watson will request clarification on allowable expenses with the consulting firm being contracted by Pottawattamie County to address CARES Act funds. At this time the board is not ready to make a decision on approval of funds as more clarification and review is needed. Motion was made by Randy Hickey and second by Chuck Morris for the leadership team to review and make recommendations for approval of the grant requests, with final board approval to be made by email vote. Motion passed unanimously.

**CARES Act Region Expenditures-** Suzanne Watson provided an outline of items the region would like to purchase with Cares Act dollars, including audiovisual equipment, computers, PPE, and renovation of the Shelby county region office door for safety. Motion made by Marilyn Drake and second by Chucky Morris to approve the outline of region purchases with COVID Act funds. Motion passed unanimously.

Region Service and Other Provider Updates: Lonnie Maguire reported that service coordination had 27 referrals in August along with 1 SOAR referral. She also announced the hiring of two service coordinators, Chasity Kephart and Miranda Wachter. Kephart will begin working on September, 28, 2020 and Wachter will being working on or around December 14, 2020. With Jail Service Coordination, staff worked with 21 clients in August. Staff continue to work from the Pottawattamie County Jail. Danelle Bruce reported that mobile crisis is now available at the Cass County Hospital emergency department. Training also took place last week to begin mobile crisis at George C. Grape Hospital in Hamburg.
